8. You need to provide your own tables, chairs, electric cords, and tents, etc.- **ELECTRICITY WILL NOT BE PROVIDED!**
9. If fees are paid and you do not show for any reason, fees are forfeited!
10. Vendors may begin setting up by 9:00 a.m. and must be open by 10:00 a.m.
11. Vendors should close booths by 3:00 p.m. and must be torn down by no later than 3:30 p.m.

Vendor shall comply with all laws, ordinances or rules and regulations of any lawful authority, agency or government entity which apply to the use of its vending unit requirements, including without limitation, any applicable fire and building code of the Village of Eagle, and health regulations of the Cass County Health Department.
