Spring Fling Metric Century Ride April 20, 2013

Your bicycle has been pining away in the basement or garage all winter. But the days are now getting longer and warmer! So dust it off, pump up the tires, and join your cycling friends for the Great Plains Bicycling Club's Spring Fling!

Spring Fling will meander through the scenic countryside between Eagle and Louisville, Nebraska. The ride follows an out-and-back route on paved roads linking Eagle, Elmwood, Murdock, South Bend, and Louisville. For a change of pace, you can start in either Eagle or Louisville (we will have pre-registration lists in both towns and you can register the day of the ride in either town). The round

trip distance between Eagle and Louisville is approximately 60 miles (a metric century). The round trip distance from Eagle or Louisville to Murdock is about 30 miles. For a shorter distance simply turn around and head back to your starting point whenever you like.



Fixed SAG support stations will be provided at Eagle, Louisville, and Murdock. Roving SAG vehicles will also patrol to provide assistance and pick up cyclists in need of a ride back to their starting point.

This is not a race (unless that is how you are wired) so feel free to ride any of the distances at any pace you find comfortable. All ages are welcome, but riders under 18 years of age must ride with a parent or guardian.
